

# Memorial Day 2010 Outdoor Art Show

Sat & Sun May 29 & 30 - 9:30 a.m. to 5:00 p.m.

Dana Point Harbor - Mariner's Village Boardwalk

Dana Point Fine Arts Association (DPFAA) Application and Show Rules

- Participants must be a current member in good standing of the DPFAA.
- Each artist must have a valid California State Board of Equalization Seller's Permit.
- Artists must display their art and maintain their spaces in a professional manner. Artists must not create a hazard to the public, other artists, or themselves. All packing materials, boxes, and items not part of your art display must be covered or returned to your vehicle. Pet animals are not allowed.
- Artwork must be framed, matted, or canvas gallery-wrapped, painted along the sides. Only framed or gallery-wrapped art may be displayed on A-frames. Only two-dimensional art may be shown. Artwork must be created by the participant. Reproductions must be marked as such. Crafts are not allowed.
- Only A-frames, up to 6-½ feet high, are allowed for displaying artwork. A-frames are allowed along the back section of the space, provided there is no disruption to public access ways. A small table (with tablecloth that must hang to the ground), chairs, and bins are acceptable. No artwork may be placed on the concrete or propped against objects, easels, tables, bins, columns, etc. No canopies or umbrellas are allowed in the Boardwalk Area. Artists must keep setup, including chairs, inside the center line of the sidewalk and within the side perimeter lines of the exhibit space. Sufficient room (a minimum of 30-inches) shall be maintained between adjacent spaces to allow viewing access for the public. This means that each artist may need to provide about 15-inches of space toward this mutually shared corridor.
- Artist must be completely set up by 9:30 a.m. and must stay until the show's end (5:00 p.m.). Breakdown of setups before 5:00 pm is not allowed. Should there be special circumstances regarding these times, see the outdoor chairperson.
- Any unusual occurrence should be reported to the "Art Cop" in your section. Art Cops are identified in the paperwork sent to you after your acceptance in the show. Do not discuss show details with harbor merchants or their employees.
- Artists will be charged 10% commission on all sales made. Artists who use the DPFAA credit card machine will be charged an additional 5%. The funds will be collected at the end of the event by the outdoor chairperson. Artists must comply with all show rules as stated above. For non-compliance, an artist may be asked to leave the show and may be prohibited from participating in future shows sponsored by the Dana Point Fine Arts Association.
- Should the event be rained out, no refund of the entry fee will be made.
- The Show chairperson and board have final authority for decisions on the selection of show participants, space assignments, and resolutions of show-related conflicts or issues.
- **Application Acceptance Dates: Friday April 16.** NOTE: Applications postmarked prior to this date will not be accepted, and will be returned along with the entry fee. No facsimile or marked up old applications will be accepted; current application must be obtained from newsletter mailing or DPFAA website (www.danapointfinearts.org).
- **Application Deadline Date: Friday May 14**
- **Refund Deadline Date:** No refunds will be made after **Friday May 21.** If there is a need to cancel your participation in the show, contact the Outdoor Chairperson Frank Stockl (949-363-5247)
- **Space Fees:** \$40 per day

- **Enclose:** #10 (legal) self-addressed and stamped envelope and a check (made payable to DPFAA) for space fee. Participating artists will receive their space assignment, map, and instructions in their return envelope.
